Open A: Race to 4 (Finals race to 5)

Entry Fee \$40.00 + \$7 Admin fee (\$47) - Start Time Fri. 5:00 PM

Open B: Race to 3 (Finals race to 4)

Entry Fee \$20.00 + \$7 Admin fee (\$27) - Start Time Fri. 3:00 PM

Open C: Race to 3 (Finals race to 3) To play in the C division, a player can NOT have any Eight Ball Run Outs. If ERO's are NOT tracked then can not have any Table Runs on their record for this league season. As of the tournament deadline date.

Women's AA/A: Race to 4 (Finals race to 5) (AA spot A - 1 game) (AAA Women to play in minimum of Open A)

Entry Fee \$40.00 + \$7 Admin fee (\$47) - Start Time Fri. 5:00 PM

Women's B: Race to 3 (Finals race to 4)

Entry Fee \$20.00 + \$7 Admin fee (\$27) - Start Time Fri. 3:00 PM

Women's C: Race to 3 (Finals race to 3) To play in the C division, a player can NOT have any Eight Ball Run Outs. If ERO's are NOT tracked then can not have any Table Runs on their record for this league season. As of the tournament deadline date.

Entry Fee \$20.00 + \$7 Admin fee (\$27) - Start Time Fri. 1:00 PM

Any player who signs up for improper division based off the Rocky Mountain players list will be ejected from tournament at point of discovery. Player will forfeit any prize money and entry fee. This also pertains to players of "known ability".

LATE FEES & WITHDRAWAL FEES

There will be a \$40 late fee charged per player that signs up past the deadline date. Players will only be added if there are spots available (ie TBA's; BYEs are not considered a spot to be replaced). Once brackets are posted, no one can purchase a spot. A \$10 fee will be charged to any player withdrawing from the tournament between the deadline date and Thurs. Nov. 1st. After Thurs. Nov. 1st any player withdrawing from the tournament will be charged their complete entry amount. A player withdrawing from the tournament can "sell his spot" to someone who is of equal ranking and from the same charter holder.

- 2nd chance tournament for some divisions for players that have been eliminated in 3 rounds or less. Entry fee and format to be announced at tournament.

Open to VNEA Sanction Active Players ONLY - VNEA Tournament Rules Apply

Flip for first break, thereafter alternate break — all matches will be "Rack You Own" breaks

All players must have played in 25% of scheduled matches as of tournament date. *Players under the age of 21 must play in the upper skill levels of B or above. A player can not play in the regular tournament & the junior tournament.* For more info contact your local VNEA operator. Entries must be made to your local operator.
